Terms and Conditions :

1. The bid should be submitted in a sealed cover superscribed as “**Tender for Auction of Diplomatic Car**” and addressed to “Head of Chancery, High Commission of India, Colombo, 36-38 Galle Road, Colombo-03. **The last date of submission of bids is 30.04.2025 (1400 hrs.).** Earnest Money Deposit (EMD) by cheque / DD for **SLR 40,000/-** in favour of ‘**High Commission of India, Colombo**’ is required to be deposited along the bids. MSMEs are exempted from depositing of EMD and are required to furnish the ‘Bid Declaration Form’ as per **Annexure-II**. EMD of unsuccessful bidders shall be returned within 30 days of declaration of result of auction. The Bid should contain:-

(a) General Information of the bidder as per **Annexure III**.

(b) The Financial Bid clearly mentioning the bid price in Sri Lankan Rupees in both figures and words. The bid must be valid for at least 90 days.

2. The bid will be confirmed in favour of the person quoting the highest rate in respect of the vehicle.

3. The bids will be opened on 30.04.2025 at 1500 hrs.

4. 50% of the bid amount is to be deposited by the highest bidder immediately, being declared successful, by way of bank transfer (the details of bank account will be shared with the successful bidder).

5. On final acceptance of the bid, the remaining 50% amount (including VAT and Duty) is to be deposited by the successful bidder within one week of communication of acceptance to him, failing which 50% amount already deposited shall stand forfeited. After the deposit, the vehicle will be handed over to such person, after executing necessary documents. The successful bidder shall make his own arrangement for the purpose of taking delivery of auctioned vehicle.

6. Conditional bids will not be entertained.

7. High Commission of India, in its discretion, reserves the right to reject or accept any or all the bids, at any time, without assigning any reason thereof.

8. It shall be presumed that the bidder has fully inspected the car before the auction. Embassy of India will not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.

9. The Officers/staff of High Commission of India and their family members shall not be permitted to participate in the auction.

10. The successful bidder shall get the vehicle transferred in his/her name as per rules, at his own cost and responsibility. High Commission of India shall not in any manner be concerned with or responsible for registration of the vehicle, and will have no liability whatsoever.
