- 2. Interested firms are requested to submit their bids in a sealed envelope **on or before 24.11.2025 (1000 hrs)**. The bid should contain details including brand name, full specifications along with cost of equipment and other charges, if any, in Sri Lankan Rupees. The bid must be addressed to "**Defence Adviser**, **High Commission of India**, **No. 36-38**, **Galle Road**, **Colombo-03**".
- 3. The bids shall be opened at **1500** hrs on **24.11.2025** at the High Commission of India, Colombo.
- 4. This is a lumpsum fixed price tender. The bidder should examine the specific requirements mentioned in para 1 above before submitting the bid. No escalation in price shall be allowed after submission/acceptance of bid.
- 5. **Bid validity**: The bids must be valid for a period of Sixty (**60**) days from the date of opening of bids.
- 6. **Earnest Money Deposit:** Along with the bid, the bidder shall submit a Bank Guarantee (as per Annexure-A) amounting to **SLR 1,19,935/-** (Sri Lankan Rupees One Lakh Nineteen Thousand Nine Hundred and Thirty Five only). The EMD must be valid for 30 days beyond the bid validity period (i.e., last date of bid submission + 90 days). If a bid is withdrawn after submission, the earnest money deposited by the applicant will be forfeited. Bids submitted without earnest money shall be summarily rejected. EMD in respect of all unsuccessful applicants shall be returned without any interest, after the issuance of purchase order to the successful bidder. In case of the selected bidder, the EMD shall be returned on submission of performance guarantee by them.
- 7. **Performance Security**: The selected bidder shall deposit a performance security in the form of an unconditional and irrevocable Bank Guarantee (as per Annexure-B) equal to 5% of Accepted Tender Amount. This bank guarantee must be valid up to 30 days beyond the completion of defects liability period / warranty period.
- 8. **Defects Liability Period (Warranty)** will be at least 24 months from the date of completion of the job of supply and installation of all items listed in Purchase Order. The supplier is bound to rectify/replace the defective item, which may come to notice during defects liability period, free of cost. In case of non-compliance of removal/rectification/replacement of defective item, the High Commission of India shall

have the right to forfeit full or part of performance guarantee.

- 9. **Completion period**: The successful bidder shall supply and install all said items within Fifteen (15) days from the date of issue of Purchase Order.
- 10. The High Commission of India, Colombo reserves the right to accept or reject any bid at any stage of the tender or to cancel the tender without assigning any reason.
