Tender Notice

High Commission of India, Colombo invites sealed quotations under the two bid system (technical and financial) from authorized dealers/sales agents of Original Indian Manufacturers based in Sri Lanka for supply of 10,000 nos. push bicycles (7,000 gents and 3,000 ladies). The supplier needs to have existing spare parts sales outlets in the Island, particularly in Northern Province.

Bidders may purchase the Tender Documents from the address mentioned below, against payment of SLR 1,000.00 (non-refundable) in cash or in the form of Demand Draft drawn in favour of High Commission of India, Colombo. These can also be downloaded from the Mission's website www.hcicolombo.org, in which case a draft for SLRs.1,000/- drawn in favour of High Commission of India towards the fee of tender documents may be enclosed with the technical bid.

Bids (technical and financial) may be submitted in a sealed cover marked "**Tender for** supply of Bicycles to Northern Province of Sri Lanka" so as to reach latest by 1500 hrs on 30th May, 2011. All tenders received after the deadline will be rejected.

The technical bid and the financial bid documents (**in duplicate**) should be sealed by the bidder in separate covers duly superscribed thus and both these sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed. The bid may be deposited with the undersigned at the High Commission of India. The bid may include all the details and meet terms and conditions as listed in the tender documents.

The sealed quotations (technical bids) will be opened in presence of authorized representatives of bidders <u>at 1530 hrs on 30/05/2011</u> in the High Commission of India.

Terms and Conditions

- 1. Sealed quotations may be submitted under the two bid system (technical and financial) by authorized dealers/sales agents of Original Indian Manufacturers based in Sri Lanka for supply of 7,000 Gents and 3,000 Ladies bicycles (as per mentioned specifications in Annexure-A & B).
- 2. The supplier needs to have pre-existing spare parts sales outlets in the island, particularly in Northern Province. The supplier must also arrange for transportation of cycles to designated distribution points in Northern Province at his own expense and provide temporary storage/warehousing in Colombo/Northern Province, if required. The cost for the same must be shown separately in the price schedule form (Annexure-C)
- 3. A certificate guaranteeing that adequate amount of spare parts will be available in the North for at least seven years from the date of supply may be provided along with the technical bid.
- 4. Bidders are requested to submit their bid (technical and financial) in a sealed cover marked "Tender for supply of bicycles to Northern Province of Sri Lanka" so as to reach latest by 3.00 P.M. on 30th May 2011. The technical bid and financial bid should be sealed by the bidder in separate covers duly superscribed thus and both these sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed.
- 5. The bid may be submitted to Attaché (Commerce), High Commission of India, 36-38, Galle Road, Colombo-3 and acknowledgement obtained.
- 6. OPENING OF BIDS: The sealed quotations (technical bids) will be opened in presence of authorized representatives of bidders at 3.30 PM on 30/05/2011 in the High Commission of India. After scrutiny of technical bids by the Tender Evaluation Committee, financial bids of only those bidders who qualify the technical evaluation will be opened at a time and date to be intimated later.
- 7. **EARNEST MONEY DEPOSIT (EMD)**: Technical bids should contain EMD of SLR 1,200,000 by DD/PO drawn in favour of High Commission of India, Colombo. Alternatively, a standard bid guarantee (format as in **Annexure E**) issued by a bank or an insurance agency approved by the Central Bank of Sri Lanka, in favour of the Indian High Commission, Colombo of this amount may be provided. The Bid Guarantee of all unsuccessful bidders will be released after the tender is finalized. The Bid Guarantee should be valid for a minimum period of 90 days from the date of opening of tenders. Technical bids without Earnest Money Deposit/Bid Guarantee will be rejected.

- 8. **PERFORMANCE GUARANTEE**: The successful bidder shall submit, within fourteen working days after the award of tender, a Performance Guarantee (format as in **Annexure F**) provided by a reputed bank or an insurance agency approved by the Central Bank of Sri Lanka, of an amount equal to ten percent (10%) of the value of order, drawn in favour of the High Commission of India, Colombo for the due execution of the contract within the specified period. The Performance Guarantee should be valid for a period of 120 days from the date of award. If the Performance Guarantee is not submitted within 14 days of the letter of award, the award will be cancelled and the Guarantee will be forfeited. The EMD of the bidder, whose tender is accepted, will be discharged when the said bidder's Performance Guarantee has been accepted.
- 9. **RETENTION MONEY:** Retention money to the extent of 5% of invoice amount will be retained up to the warranty period or one year (whichever is earlier) and released thereafter, subject to proper functioning of supplied equipments and satisfactory after sales service.
- 10. **VALIDITY AND CURRENCY OF BIDS:** All bids shall hold good for acceptance for a minimum period of 90 days from the date of closing of tender. The price quoted should be in Sri Lanka Rupees and written clearly in ink or typewritten. The total amount of the bid should be given in words as well as in figures.
- 11. The quoted price (as of the point of delivery indicated in Delivery schedule, **Annexure -C)** should be exclusive of all taxes, duties and levies etc. However, the taxes, duties and levies etc. as applicable may be quoted separately. The VAT Registration number should be indicated, if registered for VAT. Otherwise, the tender is liable to be rejected. If the bidder is not registered for payment of VAT, a certificate to that effect, obtained from the Commissioner General of Inland Revenue, should be annexed to the tender.
- 12. The bidder may provide the following:

With the Technical Bid:

- (i) Self-attested photo-copy of registration of the company/firm/ proprietorship with the concerned Sri Lankan / Indian authorities.
- (ii) Annual Report (where statutorily required to be filed), and Financial Reports for the last 2 years, preferably audited ones.
- (iii) Details of experience in similar field in Sri Lanka or in India
- (iv) Document to support the country of origin declaration in the Price Schedule form, where applicable.
- (v) Manufacturer's authorization letter authorizing the bidder to supply the

goods.

- (vi) Documentary evidence to establish conformity of the goods to the technical specifications in the bidding documents along with the Technical Specification Form (**Annexure A&B**).
- (vii) Documents and information as required in the Bidder Information Form (**Annexure D**)
- (viii) The bidder shall also furnish a list giving full particulars, including available sources and current prices of spare parts, special tools, etc., necessary for the proper and continuing functioning of the goods during the warranty period.
- (ix) EMD as mentioned in paragraph 7 above (the bid will be rejected if the EMD is not submitted in the Technical Bid envelope)

With the Financial Bid:

- (i) Price quotation in the Price Schedule Forms (as in **Annexure C**)
- 13. Any alteration or deletions in the bid should be authenticated by the <u>full</u> <u>signature</u> of the bidder.
- 14. **WARRANTY:** The item offered should carry a comprehensive warranty as per specification. Any deviation in the warranty period should be indicated.
- 15. **MODE OF PAYMENT:** Payments will be released only after the items as tendered are handed over/delivered at designated places in Colombo or Northern Province in perfect working condition, to the High Commission of India or its authorized representative.
- 16. **DELIVERY:** The successful bidder must complete delivery, as stipulated above, of 50% of the order quantity within 30 days and the balance within 45 days from the date of award of contract. Payment will be done only after successful supply and commissioning of equipment at designated places within the Northern and Eastern Provinces of Sri Lanka. The exact places and the quantities to be supplied there will be intimated by the High Commission later. If the successful bidder fails to hand over within the stipulated period, liquidated damages @ 1% of the tender amount shall be levied for a delay of each calendar week or part thereof, subject to a maximum of 10%.
- 17. **ACCEPTANCE OF TENDERS:** The High Commission of India reserves the right to reject any or all tenders or accept any tender or a part thereof without assigning any reason whatsoever.
